

NephroPlus, India's Largest Dialysis Network Acquires Majority Stake in Royal Care Dialysis Centers, Philippines

Mumbai, 13th **October, 2020:** NephroPlus, India's largest dialysis network and a trailblazer in redefining dialysis care in India announced its first major overseas acquisition. NephroPlus acquired majority stake in Royal Care Dialysis Centers, Inc (RCDC), a reputed dialysis network in the Philippines with deep focus in delivering high quality care. Through this strategic partnership, NephroPlus has become the 1st Indian dialysis network to expand overseas, marking the company's transition to becoming a Multi-National Corporation (MNC).

With this entry into Philippines, we reiterate our commitment to build a dominant multinational network across Asia, Middle East and CIS geographies."
